FFP FIRE PIT Rules • Restrictions • Regulations (PLEASE READ CAREFULLY)

1. APPLICANT MUST BE 18 YEARS OR OLDER TO APPLY FOR AN FFP FIRE PIT USE PERMIT.
2. ALCOHOLIC BEVERAGES ARE STRICTLY PROHIBITED.
3. ONLY CLEAN DRY WOOD CAN BE BURNED. THE BURNING OF GARABAGE, TRASH, REFUSE, TREATED WOOD, PLASTIC RUBBER, CONSTRUCTION DEBRIS, AND FLAMMABLE AND OR COMBUSTIBLE LIQUIDS IN ANY FORM IS STRICTLY PROHIBITED AND IS SUBJECT TO FINES.
4. BURNING IS PROHIBITED WHEN THE WIND IS IN EXCESS OF 10 MPH AS DETERMINED BY THE NATIONAL WEATHER SERVICE. (<https://www.weather.gov>)
5. FIRE EXTINGUISHING EQUIPMENT IS THE RESPONSIBLTY OF THE APPLICANT AND SHOULD BE READILY AVAILABLE AS IT MAY BE NECESSARY FOR THE TOTAL CONTROL OF THE FIRE. EXAMPLES INCLUDE BUT ARE NOT LIMITED TO; BUCKET OF WATER, GARDEN HOSE, OR FIRE EXTINGUISHER.
6. BURNING MUST BE ATTENDED AT ALL TIME BY A PERSON AT LEAST EIGHTEEN (18) YEARS OF AGE UNTIL THE FIRE HAS BEEN FULLY EXTINGUISHED.
7. BURNING SHALL NOT CREATE SMOKE THAT CAUSES A PUBLIC NUISANCE OR A VISIBLTY HAZARD TO ANY PATHWAYS OR EXITS. THE FFP FIRE PIT SHALL BE EXTINGUISHED AT THE REQUEST OF THE FIRE DEPARTMENT AND ITS PERSONEL.
8. WHEN WEATHER CONDITIONS WARRANT, THE FIRE CHIEF, MAY DECLARE A BURNING BAN.

9. ALL VEHICLES SHOULD BE PARKED IN THE DESIGNATED PARKING AREAS PROVIDED AT THE FFP. NO CARS, TRUCKS AND OR COMMERCIAL VEHICLES ARE PERMITTED TO PARK OR DRIVE TO THE FFP FIRE PIT.
10. ALL TRASH, PERSONAL ITEMS AND OR BELOGINGS SHALL BE TAKEN OUT BY THE APPLICANT AND THE FFP FIRE PIT AREA WILL BE LEFT CLEAN AND READY FOR USE.
