# FRELINGHUYSEN TOWNSHIP LAND USE BOARD Minutes-January 9, 2023

## CALL TO ORDER:

The meeting was called to order at 7:30 p.m. by the secretary Brenda Kleber.

## ANNOUNCEMENT OF PROPER NOTICE:

## ROLL CALL:

## NOMINATION FOR CHAIRMAN:

The secretary called for nominations for Chairman. Motion was made by Mr. DeCarolis, seconded by Mr. Rogers to nominate Martin Connor. There being no further nominations Mr. Connor accepted and the nominations were closed. All were in favor.

## NOMINATION FOR VICE CHAIRMAN:

Mr. Connor asked for nominations for Vice Chairman. Motion was made by Mr. Stock, seconded by Mr. DeCarolis to nominate Daniel Rogers. Motion was made by Mr. Forbes, seconded by Mr. Stracco to nominate Donald Soisson. A ballot vote was taken with

Motion was made by Ms. Caruso, seconded by Mr. Stock to appoint Darlene Green of Colliers Engineering at a rate of \$160.00 per hour as board planner. All were in favor with Mr. Forbes abstaining and Mr. DeCarolis voting no.
