CALL TO ORDER:

Veda Farms, Application #2022-03, Block 301, Lots 6 & 6.01.

Appearing before the board was attorney Nicole Voight and founder & CEO Smrita Choubey. At this time, Mr. Stock recused himself and left the building. Ms. Voight stated that Veda Farms intends to purchase Murlan Farms at 175 Kerrs Corner Road in order to grow organic medicinal herbs along with a cannabis cultivation facility. The property consists of 226.88 acres of which the applicant will use 11 acres for the facility. They are requesting two variances: 1) use variance to permit cannabis cultivation in the AR6 zone and 2) use variance to allow cannabis to be cultivated outdoors. Motion was made by Mr. Soisson, seconded by Mr. Klein to deem the application complete. A condition would be that a T C C meeting be held before the hearing.
