# #2024-22 RESOLUTION TO APPOINT TEMPORARY QUALIFIED PURCHASING AGENT

#### **ORDINANCES:**

#2024-01 CALENDAR YEAR 2024 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14) WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and, WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and, WHEREAS, the Township Committee of the Township of Frelinghuysen in the County of Warren finds it advisable and necessary to increase its CY 2024 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and, WHEREAS, the Township Committee hereby determines that a 1.0% increase in the budget for said year, amounting to \$9,055.07 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and, WHEREAS the Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years. NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Frelinghuysen, in the County of Warren, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2024 budget year, the final appropriations of the Township of Frelinghuysen shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$31,692.75, and that the CY 2024 municipal budget for the Township of Frelinghuysen be approved and adopted in accordance with this ordinance; and, BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and, BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and, **BE IT FURTHER ORDAINED**, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption. **CERTIFICATION** I, Donna Zilberfarb, Municipal Clerk of the Township of Frelinghuysen do hereby certify the above to be a true copy introduced by the Frelinghuysen Township Committee at a meeting held on January 3, 2024 and was adopted on final reading at the meeting of the Frelinghuysen Township Committee held on February 21, 2024 at 6:00 pm at the Municipal Building, 210 Main Street, Johnsonburg, New Jersey. #2024-02 AMENDING SECTION 2-11.4 OF THE TOWNSHIP OF FRELINGHUYSEN CODE CONCERNING THE POWERS AND DUTIES OF THE TOWNSHIP CLERK WHEREAS, the Section 2-11.4 of the Township of Frelinghuysen Code specifies the powers and duties of the Township Clerk; and WHEREAS, N.J.S.A. 40A:9-133(e)(7) provides that a municipal clerk shall perform such duties as are imposed by statute, ordinance or regulation; and WHEREAS, it is necessary and appropriate to amend that section to reflect duties necessary for the Township's operations, and

which are to be performed by the Township Clerk. NOW, THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Frelinghuysen, County of Warren, State of New Jersey, as follows: Section I Section 2-11.4 of the Township of Frelinghuysen Code, is amended to read as follows (additions are boldfaced, deletions are stricken through): § 2-11.4. Powers and Duties Specified. The Township Clerk shall:...g. Serve as the Assessment Search Officer; h, Serve as the Secretary to the Board of Health; i. Serve as the Safety Director, and j.g. Perform such other duties as are now or hereafter imposed by statute, regulation or by municipal ordinance or regulation. Section II

- 1. Each clause, section or subsection of this ordinance shall be deemed a separate provision to the intent that if any such clause, section or subsection should be declared invalid, the remainder of the ordinance shall not be affected.
- 2. All ordinances or parts of ordinance inconsistent with this ordinance are hereby repealed as to the extent of such inconsistency.
- 3. This Ordinance shall take effect twenty (20) days following final passage, approval, and publication as required by law. There was no old business discussed

# **NEW BUSINESS:**

- Mr. MacNamara handed out packets listing all the calls for Frelinghuysen and surrounding townships. He introduced Lorrie Kuntz and explained the ambulance corps budget and purchasing of a used vehicle last year, looking at a new load system and the normal wear and tear on the equipment which are all costs for their budget. He explained that they raise 75% of their funding on their own and rely on surrounding towns for the remaining 25%. He stated that they were happy with the \$6,000.00 from the previous years. Mr. Stracco asked about insurance and charging residents. Mr. MacNamara explained that they do not charge over the insurance charges to the residents of the towns that give donations to them. Mr. Stracco asked about the disproportionate man hours and that the second highest being Hope and asked if he could explain. Mr. MacNamara explained it was due to Route 80, the State Police barracks and the Land of Make Believe calls. No one in the public had questions for the ambulance corps. Mr. Ramos thanked him for his time and appreciated them coming in.
- Motion was made to concur the Mayor appointments as follows by Mr. McPeek, seconded by Mr. Stock. All were in favor. All appointments are effective as of February 21, 2024.
  - Bruce Barbour to the Environmental Commission as Alternate #1
  - Bruce Barbour to the Open Space / Farmland Committees as Alternate #2
  - Anthony Tolosi to the Recreation Committee as Alternate #2
  - Robert Halberstadt as fire fighter
  - Pastor Marc Siegel as the Fire Company Chaplain
- Beth Styler discussed the removal of the dam in Paulina and explained how the work has progressed. Presently there is a notch of about 50 feet to narrow the dam area. She explained the sediment and how it works and explained they may need to dredge alittle this summer. No work will be done until July 2<sup>nd</sup> as the river needs time to settle. July through December there will be a lot of activity. Trees will be planted, protection at the rail bridge will be completed as well. Paula Jensen asked that the basic reason the dam was removed was because of lack of use and too much money? Ms. Styler explained this project started in 2015-16 and was the decision of Blairstown Township. Loren Greco asked if there were any thoughts on removal of

the rail bridge. Ms. Styler stated no removal will be done. He also asked about the smaller dam by the elementary school. Ms. Styler explained that it was put in by USGS, US geological survey and that it was put in to raise the pool behind it. She explained that because shad can get over it there is no reason to remove it. There were no more questions from the public. Mr. Ramos thanked Ms. Styler for updating the township.

• The Mayor swore in Frankie Giordano and Robert Halberstadt to the FTVFC. When the oaths were completed, Mr. Ramos read a statement discussing the establishment of the fire department and named all Committee members, Captain Jim Burns, Chief Ortiz and all the volunteers within the department that made this possible. He announced that the FTVFC would be rolling out as active as of March 1, 2024.

#### **DEPARTMENT REPORTS:**

Motion was made by Mr. Stracco for a consent agenda for department reports 1-16 with the exception of #11 the land managers report, seconded by Mr. McPeek. All present were in favor. Mr. Connor read his report on the request of Ms. Natyzak.

### **OPEN MEETING TO THE PUBLIC:**

Motion was made by Mr. Stracco, seconded by Mr. Stock limiting it to 20 minutes to open meeting to the public. All were in favor. Spoke were:

- Dan Kohuth asked about resolutions 2024-21 and 2024-22 and who was appointed and asked if that would be published out in the minutes. Mr. Ramos stated who they were and that those would be in the minutes.
- Mr. Kohuth asked about Road Safety systems and if those guardrails were hit by dying ash trees. Mr. Ramos explained they were from hit and run accidents and were from last year.

Motion was made by Mr. Stracco, seconded by Mr. McPeek to close to the public. All were in favor.
