#2021-01 CALENDAR YEAR 2021 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14) WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 1.0% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and, WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and, WHEREAS, the Township Committee of the Township of Frelinghuysen in the County of Warren finds it advisable and necessary to increase its CY 2021 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and, WHEREAS, the Township Committee hereby determines that a 1.0% increase in the budget for said year, amounting to \$8,881.27 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and, WHEREAS the Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years. NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Frelinghuysen, in the County of Warren, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2021 budget year, the final appropriations of the Township of Frelinghuysen shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$ 31,084,45, and that the CY 2021 municipal budget for the Township of Frelinghuysen be approved and adopted in accordance with this ordinance; and, **BE IT FURTHER ORDAINED**, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and, BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and, BE IT FURTHER **ORDAINED**, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption. **CERTIFICATION**

#2021-05 TOWNSHIP OF FRELINGHUYSEN BOND ORDINANCE BOND ORDINANCE PROVIDING FOR VARIOUS 2021 CAPITAL IMPROVEMENTS, BY AND IN THE TOWNSHIP OF FRELINGHUYSEN, IN THE COUNTY OF WARREN, STATE OF NEW JERSEY; APPROPRIATING \$165,500 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$157,225 BONDS OR NOTES OF THE TOWNSHIP TO FINANCE PART OF THE COST THEREOF BE IT ORDAINED AND ENACTED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF FRELINGHUYSEN, IN THE COUNTY OF WARREN, STATE OF NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

SECTION 1. The improvements or purposes described in Section 3 of this bond ordinance are hereby authorized as general improvements or purposes to be undertaken by the Township of Frelinghuysen, in the County of Warren, State of New Jersey (the "Township"). For the said improvements or purposes stated in Section 3, there is hereby appropriated the sum of \$165,500, said sum being inclusive of a down payment in the amount of \$8,275 now available for said improvements or purposes required by the Local Bond Law, N.J.S.A. 40A:2-1 et seq., as amended and supplemented (the "Local Bond Law"), and now available therefor by virtue of a provision or provisions in a previously adopted budget or budgets of the Township for down payment or for capital improvement purposes. SECTION 2. For the financing of said improvements or purposes described in Section 3 hereof and to meet the part of said \$165,500 appropriation not provided for by said down payment referred to in Section 1 hereof, negotiable bonds of the Township are hereby authorized to be issued in the principal amount of \$157,225 pursuant to the Local Bond Law. In anticipation of the issuance of said bonds and to temporarily finance said improvements or purposes, negotiable notes of the Township in a principal amount not exceeding \$157,225 are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law. SECTION 3. (a)

The improvements hereby authorized and purposes for the financing of which said bonds or notes are to be issued is the 2021 Capital Improvement Program, which includes, but is not limited to: (i) acquisition of turnout gear and air cylinders for use by the Blairstown Fire Department; (ii) acquisition of miscellaneous apparatus equipment for use by the Hope Fire Department; (iii) repairs and improvements to various roadways in the Township, including, but not limited to, paving, cross drains, tarring and chipping; (iv) acquisition and installation of street signs within the Township; (v) acquisition of miscellaneous tools for use by the Department of Public Works; (vi) various repairs and improvements to the town hall deck; (vii) oil tank repairs and refinishing; (viii) repairs and painting of town garage; (ix) various improvements to the Morton Building within the Township, including, but not limited to, the acquisition and installation of concrete flooring; (x) improvements to Ramsey Road within the Township, including, but not limited to, the acquisition and installation of a standpipe system; and (xi) various improvements and upgrades to the Recreational Field, including, but not limited to, extension of the softball field and the acquisition and installation of new soccer goals. Such improvements or purposes shall also include, as applicable, all engineering and design work, surveying, construction management services, preparation of plans and specifications, permits, bid documents, contract administration, and all work, materials, equipment, labor and appurtenances necessary therefor or incidental thereto, all in accordance with the plans therefor on file in the office of the Township Clerk and available for public inspection and hereby approved.

(b) The estimated maximum amount of bonds or notes to be issued for said improvements or purposes is \$157,225. (c) The estimated cost of said improvements or purposes is \$165,500, the excess thereof over the said estimated maximum amount of bonds or notes to be issued therefor being the amount of \$8,275, which is the down payment available for such improvements or purposes.

SECTION 4. In the event the United States of America, the State of New Jersey, and/or the County of Warren make a contribution or grant in aid to the Township for the improvements or purposes authorized hereby and the same shall be received by the

Township prior to the issuance of the bonds or notes authorized in Section 2 hereof, then the amount of such bonds or notes to be issued shall be reduced by the amount so received from the United States of America, the State of New Jersev and/or the County of Warren. In the event, however, that any amount so contributed or granted by the United States of America, the State of New Jersey and/or the County of Warren shall be received by the Township after the issuance of the bonds or notes authorized in Section 2 hereof, then such funds shall be applied to the payment of the bonds or notes so issued and shall be used for no other purpose. This Section 4 shall not apply, however, with respect to any contribution or grant in aid received by the Township as a result of using funds from this bond ordinance as "matching local funds" to receive such contribution or grant in aid. SECTION 5. All bond anticipation notes issued hereunder shall mature at such times as may be determined by the Chief Financial Officer of the Township, provided that no note shall mature later than one (1) year from its date or as otherwise authorized by the Local Bond Law. The notes shall bear interest at such rate or rates and be in such form as may be determined by the Chief Financial Officer of the Township. The Chief Financial Officer of the Township shall determine all matters in connection with the notes issued pursuant to this bond ordinance, and the signature of the Chief Financial Officer of the Township upon the notes shall be conclusive evidence as to all such determinations. All notes issued hereunder may be renewed from time to time in accordance with the provisions of the Local Bond Law. The Chief Financial Officer of the Township is hereby authorized to sell part or all of the notes from time to time at a public or private sale and to deliver them to the purchaser thereof upon receipt of payment of the purchase price and accrued interest thereon from their dates to the date of delivery thereof. The Chief Financial Officer of the Township is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the notes pursuant to this bond ordinance is made. Such report must include the principal amount, the description, the interest rate, the maturity schedule of the notes so sold, the price obtained and the name of the purchaser. SECTION 6. The Capital Budget of the Township is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith. In the event of any such inconsistency, a resolution in the form promulgated by the Local Finance Board showing full detail of the amended Capital Budget and capital programs as approved by the Director of the Division of Local Government Services, New Jersey Department of Community Affairs will be on file in the office of the Clerk of the Township and will be available for public inspection. SECTION 7. The following additional matters are hereby determined, declared, recited and stated: The improvements or purposes described in Section 3 of this bond ordinance (a) are not current expenses and are improvements which the Township may lawfully undertake as general improvements, and no part of the cost thereof has been or shall be specially assessed on property specially benefited thereby. (b) The average period of usefulness of said improvements or purposes within the limitations of the Local Bond Law, according to the reasonable life thereof computed from the date of the said bonds authorized by this bond ordinance, is 6.45 years. (c) The Supplemental Debt Statement required by the Local Bond Law has been duly made and filed in the Office of the Clerk of the Township and a complete executed duplicate thereof has been filed in the Office of the Director of the Division of Local Government Services, New Jersey Department of Community Affairs, and such statement shows that the gross debt of the Township as defined in the Local Bond Law is increased by the authorization of the bonds or notes provided for in this bond ordinance by \$157,225 and the said bonds or notes authorized by this bond ordinance will be within all debt limitations prescribed by said Local Bond An aggregate amount not exceeding \$3,000 for items of expense listed in Law. (d) and permitted under Section 20 of the Local Bond Law is included in the estimated cost indicated herein for the improvements or purposes hereinbefore described. SECTION 8. The full faith and credit of the Township are hereby pledged to the punctual payment of the principal of and the interest on the bonds or notes authorized by this bond ordinance. The bonds or notes shall be direct, unlimited obligations of the Township, and the Township shall be obligated to levy ad valorem taxes upon all the taxable real property within the Township for the payment of the bonds or notes and the interest thereon without limitation as to rate or amount. SECTION 9. The Township reasonably expects to reimburse any expenditures toward the costs of the improvements or purposes described in Section 3 of this bond ordinance and paid prior to the issuance of any bonds or notes authorized by this bond ordinance with the proceeds of such bonds or notes. No funds from sources other than the bonds or notes authorized herein have been or are reasonably expected to be reserved, allocated on a long-term basis or otherwise set aside by the Township, or any member of the same "Controlled Group" as the Township, within the meaning of Treasury Regulation Section 1.150-1(e), pursuant to its budget or financial policies with respect to any expenditures to be reimbursed. This Section 9 is intended to

be and hereby is a declaration of the Township's official intent to reimburse any expenditures toward the costs of the improvements or purposes described in Section 3 hereof to be incurred and paid prior to the issuance of bonds or notes authorized herein in accordance with Treasury Regulation Section 1.150-2, and no further action (or inaction) will be an abusive arbitrage device in accordance with Treasury Regulation Section 1.148-10 to avoid the arbitrage yield restrictions or arbitrage rebate requirements under Section 148 of the Internal Revenue Code of 1986, as amended (the "Code"). The proceeds of any bonds or notes authorized herein used to reimburse the Township for any expenditures toward the costs of the improvements or purposes described in Section 3 hereof will not be used directly or indirectly (i) to "refund" an issue of governmental obligations within the meaning of Treasury Regulation Section 1.150-1(d), (ii) to create, within one year, following the reimbursement of any expenditures of bond proceeds "replacement proceeds" within the meaning of Treasury Regulation Section 1.148-1 of the bonds or any other bond issue, or (iii) to reimburse the Township for any expenditure or payment that was originally paid with the proceeds of any obligation of the Township (other than borrowing by the Township from one of its own funds or the funds of a member of the same "Controlled Group" within the meaning of Treasury Regulation Section 1.150-The bonds or notes authorized herein to reimburse the Township for any 1(e)). expenditures toward the costs of the improvements or purposes described in Section 3 hereof will be issued in an amount not to exceed \$157,225. The costs to be reimbursed with the proceeds of the bonds or notes authorized herein will be "capital expenditures" in accordance with the meaning of Section 150 of the Code and Treasury Regulation Section 1.150-1. This provision will take effect immediately, but will be of no effect with regard to expenditures for costs paid outside the permitted reimbursement period set forth in Treasury Regulation Section 1.150-2(d)(2). SECTION 10. Township The covenants to maintain the exclusion from gross income under Section 103(a) of the Code of the interest on all bonds and notes issued under this bond ordinance. SECTION 11. This bond ordinance shall take effect twenty (20) days after the first publication thereof after final adoption, as provided by the Local Bond Law. - Mayor Chris Stracco Attended a meeting in Hope Township with Congressman Gottheimer and Mayors from Knowlton, Hope, Hardwick and Blairstown to discuss the Covid Relief Fund Act. This can be utilized for internet within the township.
- Deputy Mayor Ramos let the committee know that there is nothing new to report on Altice/internet at this time, the salt shed will be discussed at the special meeting being held tomorrow and that the website is revised and up to date.
- Committeeman David Boynton nothing to report
- Committeeman Frank Desiderio nothing to report
- Committeeman Todd McPeek explained that the barn at the FFP was now down and cleanup was in progress.
- Attorney Rich Beilin nothing to report
- Municipal Clerk Donna Zilberfarb nothing to report

OLD BUSINESS:

- Salt shed there is a special meeting scheduled for tomorrow (Thursday, March 18, 2021) to discuss the salt shed project.
- Mr. Beilin had nothing new to report on remote meeting protocols
- Mr. Stracco will get Mr. Beilin a copy of the survey for the property on Ramsey Road in regards to the stand pipe.
- Carter Smith, Eagle Scout project was discussed and will be held to the work session on April 7, 2021.

NEW BUSINESS:

- Interlocal PCFA agreement was presented and motion was made by Mr. Boynton to approve and authorize the Mayor to sign, seconded by Mr. Ramos. All were in favor. Ms. Zilberfarb will forward signed agreement to the PCFA.
- Warren county public works shared services agreement was presented and motion was made by Mr. McPeek to approve and authorize the Mayor to sign, seconded by Mr. Boynton. Vote: Mr. Boynton-yes; Mr. Desiderio-yes; Mr. McPeek-yes; Mr. Ramos-yes; Mr. Stracco-yes. Ms. Zilberfarb will forward the signed agreement to Warren County public works.
- Lawn care proposals were discussed and motion was made by Mr. Desiderio to approve Horitcare Pest Service, as amended, with preemergent for the clay, seconded by Mr. McPeek. All were in favor. Ms. Dyer will reach out to Horticare pest service.
- The town clean up dates will be May 24-29, 2021. Vouchers will be ready for the residents after April 15th at the townhall.
- Mr. Beilin explained the feasibility and LEAP programs and explained the study application that was made was via North Warren was by 3 of the 4 participating towns and that the law permits this to be completed without Frelinghuysen's consent. Mr. Stracco asked the question of does the town adopt a resolution and go into the application, which is for the grant, or does the town do nothing? The discussion was opened to Stephanie Bonaparte, Frelinghuysen Elementary superintendent, Kim Neuffer (FT BOE), Dave Hocking (FT BOE), Kevin Brennan (NW BOE), and other board members present. After discussion, it was determined that the Board of Education for Frelinghuysen feels the same way as in 2019 and still feels that \$30,000 is not enough to complete a true feasibility study and if cost is more where does it come from. There is no communication to the BOE only to the townships, and this includes all the elementary school districts. Regionalization and consolidation were also discussed and Ms. Bonaparte and the BOE members present were all in agreeance that there has been no communication from North Warren and only from the Mayor and Committee. Mr. Brennan will let the NW BOE know that there has been no communication to the sending districts BOE's on either of these issues. After discussion, it was determined unanimously that the township will wait until more information is available and will not move forward.
- Motion was made to accept the resignation of the OEM Coordinator, Nick Pachnos and the OEM Deputy Coordinator with regrets, Colin Kellaher by Mr. Ramos, seconded by Mr. Boynton. All were in favor.

DEPARTMENT REPORTS:

Motion was made by Mr. Boynton for a consent agenda for department reports 1-10, seconded by Mr. Ramos. All were in favor.

DPW – Nothing to report

Land Manager – Mr. Connor let the committee know that he spoke with John Parks of the NJ Audubon Society and should hear within a month for moving forward. He also discussed the crushed stone that is needed by dpw and will coordinate with Dan and Donna to get it ordered. He also started the spring house restorations.

Recreation committee – Mr. Ramos discussed that the Easter egg hunt will be on April 10th at the townhall fields, NW little league will not be using any of the fields for any practices or games this year, and that there will be one softball team for grades 3-4 this year and that soccer is going well.

EXECUTIVE SESSION:

RETURN TO REGULAR SESSION:

Mr. Stracco explained that the executive session was to discuss ongoing contract negotiations.

Motion was made by Mr. Ramos to authorize the Mayor to sign the agreement for Blairstown Hose Company, seconded by Mr. Boynton. Roll call vote: Mr. Boynton-yes; Mr. Desiderio-No; Mr. McPeek-yes; Mr. Ramos-yes; Mr. Stracco-no.

The work session meeting will be held on April 7, 2021 at 7 p.m. rather than April 14, 2021. Ms. Zilberfarb will advertise the meeting date change.

OPEN MEETING TO THE PUBLIC:

Motion was made by Mr. Boynton, seconded by Mr. Ramos to open meeting to the public limited to 20 minutes with 3 minutes per member of the public. All were in favor. Spoke were:

- Cheryl Towey, 109 Bear Creek Road, asked why agreed to switch fire departments with out taking opinions of the public. She is curious on the towns reasoning and lack of consideration of this. She also asked why the OEM's resigned and asked how much money we saved. Mr. Ramos explained that we are in negotiations between the two fire departments and town. Mr. Stracco explained that the Green Fire Department gave the right to cancel our fire coverage, per Green Township at any time. It was also stated that Ms. Towey would need to ask the OEM 's why they resigned. Mr. Ramos explained that the town has been working and negotiating on a fire agreement.
- Dave Hocking, South Street, discussed the fire at his house 2 years ago and had issues with 911 for dispatching the fire departments. He added that more notice to the public would be helpful in these situations.
- Colin Kellaher, 1 Saddle Ridge Road, asked how Mr. Hocking called 911 and explained the difference of a landline and cell phone call to 911. He also stated he resigned because he couldn't support the decision the town made and that he heard OEM was going to be OEM in Blairstown. He felt this was huge disservice to the town. Mr. Stracco explained the risk again about the coverage being cancelled at anytime and asked Mr. Kellaher about mutual aid and responding. Mr. Kellaher explained how mutual aid works. Mr. Stracco and Mr. Ramos explained how they tried to come to an agreement with Green Fire Department but with the clause of cancelling coverage at any time changed the negotiations and are looking at other options for the town.

Motion was made by Mr. Boynton, seconded by Mr. McPeek to close to the public. All were in favor.
