#2021-16 ORDINANCE OF THE TOWNSHIP OF FRELINGHUYSEN, COUNTY OF WARREN, STATE OF NEW JERSEY AUTHORIZING OPTION TO LEASE AGREEMENT FOR ELECTRICITY SOLAR FACILITY AT PROPERTY KNOWN BLOCK 201, LOT 31.01 WHEREAS, the Local Lands and Buildings Law, N.J.S.A. 40A:12-14 authorizes the lease by a municipality of any real property, capital improvements or personal property or interests therein not needed for public use to the highest bidder by open public sale at auction, or by submission of sealed bids after the required newspaper advertisements; and WHEREAS, the Township of Frelinghuysen is the owner of certain real property located at Block 201, Lot 31.01 on the Frelinghuysen Township Tax Map, a/k/a 720 State Highway 94 (the "Property"); and WHEREAS, the Property is not needed for public use; and WHEREAS, the Township Committee has determined that it is in the best interest of the Township to lease the property for a photovoltaic solar electricity generating facility and related facilities; and WHEREAS, pursuant to Resolution No. 2021-56A adopted on May 19, 2021, the Township Committee issued a Request for Proposal for Leasing Municipal Land for Solar Development; and WHEREAS, sealed responses were received on June 9, 2021; and WHEREAS, two responses were received, the highest and best response was submitted by SunPower Corporation, and the Township and SunPower Corporation thereafter negotiated the terms of an Option to Lease Agreement; and WHEREAS, it is in the best interests of Frelinghuysen Township and its residents to enter into an Option to Lease Agreement with SunPower Corporation/SunPower DevCo, LLC. NOW, THEREFORE, BE IT ORDAINED by the Mayor and Committee of the Township of Frelinghuysen, County of Warren, State of New Jersey, that: 1. The Mayor, Township Clerk and Township Attorney are hereby authorized to execute an Option to Lease Agreement concerning the Property with SunPower Corporation/SunPower DevCo, LLC in the form attached hereto at Schedule A, and to execute any other documents necessary to effectuate that Agreement. 2. This ordinance shall take effect immediately upon final passage and publication as required by law. #2021-94 RESOLUTION ADOPTING THE WARREN COUNTY MULTI-JURISDICTIONAL HAZARD MITIGATION PLAN WHEREAS, the Township of Frelinghuysen_NJ, has experienced natural hazards that result in public safety hazards and damages to private and public property and; WHEREAS, the hazard mitigation planning process set forth by the State of New Jersey and the Federal Emergency Management Agency offer the opportunity to consider natural hazards and risks, and to identify mitigation actions to reduce future risks and; WHEREAS, the New Jersey Office of Emergency Management has provided federal mitigation funds to support development of an updated mitigation plan and; Whereas, a Multi-Jurisdictional Hazard Mitigation Plan has been developed by the County Department of Public Safety and Mitigation Planning Committee and; Whereas, the Multi-Jurisdictional Hazard Mitigation Plan includes a prioritized list of mitigation actions including activities that, over time will help minimize and reduce safety threats and damage to private and public property and; WHEREAS, the draft plan was provided to each participating jurisdiction through a website hosted by Michael Baker International, Inc. (Michael Baker), the contracted vendor assisting with the planning process. Links were links also posted on the Department of Public Safety website so as to introduce the planning concept and to solicit questions and comments and to present the Plan and request comments, as required by law and; NOW, THEREFORE BE IT RESOLVED by the Township of Frelinghuysen:

- 1. The Warren County Multi-Jurisdictional Hazard Mitigation Plan, as submitted on September 14, 2021 by the Warren County Department of Public Safety to the New Jersey Office of Emergency Management and submitted on October 13, 2021 to the Federal Emergency Management Agency and subsequently approved by both agencies on November 5, 2021, be and is hereby adopted as an official plan of the County of Warren; with the required yearly updates and minor revisions recommended by the Federal Emergency Management Agency and/or the New Jersey Office of Emergency Management may be incorporated without further action.
- 2. The Township of Frelinghuysen_departments identified in the Plan are hereby directed to further pursue potential or suggested implementation of the recommended high priority activities that are assigned to their departments.
- 3. Any action proposed by the Plan shall be subject to and contingent upon budget approval, if required, which shall be at the discretion of the Township of Frelinghuysen, and this resolution shall not be interpreted so an to mandate any such appropriation.
- 4. The Township of Frelinghuysen Emergency Management Coordinator is designated to coordinate with other offices and shall periodically report on the activities, accomplishments, and progress, and shall prepare an annual progress report to be submitted to the New Jersey Office of Emergency Management. The status reports shall be submitted on a yearly basis by a predetermined date agree upon by all stakeholders.

- Cheryl Towey, Bear Creek Road, explained to the committee that she's had trouble for several years with the dpw dumping excess debris on her lawn from the drain pipe and wanted to know why that was acceptable. Mr. McPeek stated that it was the towns right of way. Ms. Towey would like to see documentation of what the ROW is and wanted to know if that was true why weren't the trees that came down taken care of by the dpw from the hurricane. Mr. Ramos stated that because this wasn't on the agenda, he felt it better to be discussed at the next meeting on Jan. 19 with legal counsel present. Ms. Towey asked why it can't be dumped further down the road and Mr. McPeek explained that is where the drain pipe is. Mr. Ramos again recommended being put on agenda to discuss further. He also explained that nothing will be done in that area until after the next meeting. Ms. Zilberfarb will add Ms. Towey to the agenda for January 19th meeting.
- Frank Desiderio asked if Danette got the pricing on the salt shed he had asked for previously. He will check at the next work session.

- Dan Kohuth asked who Colliers Engineering & Design was. Mr. Stracco explained it was Maser Consulting.
- Mr. Kohuth also asked about the absentee on the agenda. Mr. Stracco explained that Mr. Desiderio resigned at the work session. Mr. Stracco explained the process of filling the vacancy.
- Ms. Towey inquired about the two cones and the section of road that is wearing away and asked when that would be fixed. Mr. McPeek stated those cones are on the drains.
