#### **OLD BUSINESS:**

- Paul Sterbenz, Colliers Engineering, updated the committee on various engineering projects.
  - He advised that the stormwater permit report has been completed and sent to the state.
  - All conditions have been addressed on the salt shed and stated that the check could be released and let the committee know that there will be more invoices after April.
  - He discussed the 3<sup>rd</sup> phase of Greendell Road and that the award was \$125,000 and have 2 years to award the contract (from 11/2021). He let the committee know that there is approximately 6500 feet remaining to be paved and that phase 3 will cover about 3500 feet.
  - He explained that the guiderail work has been completed for phase 2. He discussed South State coming and putting the berm in and to hold check until that is completed.
     Once that is completed the check will be released and the project will be closed out. Mr. Ramos asked for a timeline rather than leaving open ended.
  - He discussed the 2023 grant application deadline approaching for July 1<sup>st</sup>. Mr. Ramos asked for more specifics for funding and Mr. Sterbenz explained a connector road, heavier traffic, public facilities on them or reconstruction of a road. Mr. Ramos is currently working on ranking roads and will look at worst.
  - Mr. Sterbenz discussed the \$136,700 that has been awarded for Camp Wasigan Road and that it is ready to go. Award at next meeting.

### **NEW BUSINESS:**

- Scott Durlester, Captain Blairstown Ambulance Corps and Lori Koonz, Assistant, gave update on the squad and how covid hurt everyone. They stated it is hard to find anyone to come in and work and came to the meeting to ask for help and support in recruiting members. He explained that they have missed about 50% of calls and mutual aid is about 12-15 miles away. They are having a hard time staffing ambulances and day crews have been the hardest that have been hit but are slowing coming back. He will send an email to to Keith for website to recruit more Emergency Medical Responders. Mr. Ramos introduced Christian Ventura, OEM deputy and ems. Mr. Ventura explained he also is an emt and they are suffering at his squad and that he is an instructor and running 3 ambulances with no mutual aid and some are waiting up to an hour. Mr. Durlester explained the size of Warren County being 362 square miles and Blairstown covers approximately 200 miles and cover Route 80 as well. Mr. Ramos explained that Mr. Ventura will be doing CPR at Founders Day and offered to have a tent area set up for Blairstown. Mr. Stock asked what is expected for anyone volunteering and Mr. Durlester explained 6-12 hour shifts and that they will take whatever hours anyone can commit to. Mr. Ramos explained that the township will help in any way and will send Mr. Durlester information on Founders Day.
- Contract for concrete work in the Morton building was awarded on a motion by Mr. Mcpeek to Swentzel Masons Inc, for \$15,400.00 seconded by Mr. Stock. All were in favor.
- Appointment of the Construction Official and Building inspector was made on a motion by Mr.
   McPeek to appoint Paul Black at \$27,000 per year effective May 1<sup>st</sup>, seconded by Mr. Boynton.
   All were in favor.
- The resignation of Joe Nemeth, DPW, was accepted with regrets on a motion by Mr. Boynton, seconded by Mr. Stock. All were in favor.
- Motion was made by Mr. McPeek to appoint a laborer part time, as needed, to Jamie DePuy at \$20.00 per hour effective April 28th, seconded by Mr. Boynton. All were in favor.

## **DEPARTMENT REPORTS: \*1-15**

Motion was made by Mr. Stock for a consent agenda for department reports 1-15, seconded by Mr. Boynton. All were in favor.

## **OPEN MEETING TO THE PUBLIC:**

Motion was made by Mr. Boynton, seconded by Mr. McPeek limiting it to 20 minutes to open meeting to the public. All were in favor. Spoke were:

- Debra Natyzak Osadca, Old Stage Road, asked what happened to Dick O'Connor and Mr. Ramos explained that he retired effective May 1<sup>st</sup>.
- Todd Pantuso, Alpha Boro, introduced himself and let everyone know that he will be running for Sheriff.
- Jerry Walker, State Park Road, discussed living in area since 1968 and spoke about the disruption being caused by dozens and dozens of dump trucks at the recently purchased 140 State Park Road property. He explained that the new owners have been chipping away at the ledge which is contiguous with route 80 and his property, and that they start working at 6 am. They are cutting trees and route 80 can now be seen. He asked about a rumor of the DEP

siting contaminated soils and asked if it is contaminated soils if anyone has contacted the new owners. He explained that he is here to find out what is going on at that property. Mr. Ramos explained that he has been made aware of this issue about a month ago and has reached out to the zoning officer. He explained that the DEP has been out to the site and that samples have been taken and are waiting for results. Mr. Ramos explained that the County and State had been out and that there is a stop and desist pending investigation. He apologized to the group and assured them that the town is very serious about this issue and that the zoning officer has been very diligent regarding this matter. He suggested putting something together on quality of life with do's and don'ts for new residents coming into the township.

- Emily Peterson, State Park Road, asked if this property is zoned for farming or commercial. Chris Stracco stated the property was in the AR zone.
- John Gesuale, State Park Road, discussed playing football with his grandchildren and that a horrible mishap could occur if the ball went into the road with the trucks coming through. He also discussed the condition of the road from Shiloh road to that property and how bad it is. Mr. Ramos understands and explained that unfortunately this can be frustrating. Mr. Gesuale also asked if they can have tandems and work on them on the property. Mr. Stracco again stated they are in an AR zone and Mr. Ramos explained that they will need to be in compliance.
- Charlotte Sliver, State Park Road, asked if the contaminated soil would be removed. John Sliver also stated that it looks like a large parking lot is being made. Mr. Ramos explained that if there is contaminated soils, it all must be removed. He advised that wetlands will be addressed and that unfortunately it was going to take time but encourage the residents to come out
- Emily Peterson explained that they removed the majority of the tree line and asked if there was anything that could be done about the noise.
- John Gesuale spoke of them rerouting a stream and Mr. Ramos stated that the DEP would handle that. Mr. Gesuale asked how long this will take. Mr. Ramos is hopeful to know something next week.
- Charlotte Sliver initially gave the benefit of doubt and realized that there are no permits. Mr.
  Ramos explained that he will be speaking with the zoning officer but hasn't personally spoken
  with the DEP. Mr. Stock suggested having the assessor look at for farmland assessment and
  remove if needed.
- John Sliver discussed disturbing the peace with the noise of dump trucks dumping, hammering
  and all that noise resonates through the valley. Mrs. Sliver also discussed several open fires
  and knows of at least 2 incidences. Mr. Boynton explained that this area used to be called
  Shiloh and asked if historic. Ms. Natyzak said that no it wasn't historic as it has never been
  documented. Ms. Natyzak also stated that for the open burns to call 911 because you must
  have a permit for it.
- Emily Peterson asked if they needed to come back to the next meeting and Mr. Ramos let the
  residents know that will get the information expedited and completed as quickly as possible.
  The residents thanked the committee.
- Debra Natyzak Osadca asked who Ingelesia on the bills list was and it was stated they were the special counsel and Dan Kohuth, Greendell Road, asked that it wasn't covered under the retainer and Mr. Ramos explained that they are special counsel not our regular attorneys so it would not be covered under the retainer.

Motion was made by Mr. Stracco, seconded by Mr. McPeek to close to the public. All were in favor.

### **EXECUTIVE SESSION:**

Motion was made by Mr. Stracco to enter into executive session, seconded by Mr. McPeek. All were in favor.

No action was taken.

Motion was made by Mr. Stracco to exit executive session, seconded by Mr. Boynton. All were in favor.

## RETURN TO REGULAR MEETING:

Mr. Ramos explained that executive session was conducted for matters of pending litigation and attorney client privilege.
