## **RESOLUTIONS:**

#2020-67 TOWNSHIP OF FRELINGHUYSEN, COUNTY OF WARREN, STATE OF NEW JERSEY

RESOLUTION OPPOSING REALLOCATION FROM THE STATE RECYCLING FUND WHEREAS the international markets for recycled materials have all but collapsed; and WHEREAS, not enough domestic market capacity exists; and WHEREAS, this market crisis has resulted in tipping fees for single stream recycling in the range of \$75 to \$100 per ton and higher, thus being equivalent to and, in some cases exceeding, the cost of disposal, and WHEREAS, New Jersey towns have been forced to scramble under severe budget constraints to cover unanticipated costs to maintain these mandated recycling services to their residents; and WHEREAS, the New Jersey State Recycling Fund provides an estimated \$24 million to municipalities and counties to fund mandated and essential recycling services to their constituents; and WHEREAS, the impact of COVID-19 and subsequent business and government shutdowns have substantially increased the residential recycling generation rates due to work from home policies and orders; and WHEREAS, the lack of recycling markets along with higher volumes have the potential for further straining municipal budgets in the coming years; and WHEREAS, Governor Murphy's proposed reallocation of \$12 million to state park management will severely cut the grant amounts available and will have a negative impact on local budgets, as recycling is mandated by state law; and WHEREAS, now is not the time to further compromise municipalities' ability to meet state recycling mandates; and WHEREAS, the Township Committee of the Township of Frelinghuysen, Warren County are concerned that reduction of \$12 million from the State Recyling Fund will impair its ability to maintain an adequate recycling program; and NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the Township of Frelinghuysen, Warren County, oppose the reallocation of any and all monies from the State Recycling Fund. BE IT FURTHER RESOLVED that the Clerk forward a certified true copy of this resolution to the New Jersey Secretary of State; the Governor of the State of New Jersey; the President of the New Jersey State Senate; the Speaker of the General Assembly; the Warren County Legislative Delegation, the New Jersey Association of Counties, all other Boards of Chosen Freeholder, ANJR and Warren County Municipal Clerks. **CERTIFICATION** I hereby certify the above to be a true copy of a resolution adopted by the Township Committee of the Township of Frelinghuysen, County of Warren, State of New Jersey on September 16, 2020.

## **COMMITTEE REPORTS:**

- Mayor Chris Stracco stated that the municipal courts contracts have been signed and sent to Belvidere and he will follow up with the attorney to make sure Belvidere signed the contracts. The Green Township Fire truck will be discussed in executive session. He had nothing further to discuss.
- Deputy Mayor Ramos continues to have close contact with Altice.
- Committeeman David Boynton asked if the town would be hosting Halloween like in the
  past. Mr. Stracco explained that we are still waiting for guidance from the State but that
  he and OEM have drafted somethings and will be ready for discussion at the work
  session in October. Mr. Boynton also discussed a tree on South Street that is dead
  and feels should be taken down. He also discussed a branch on Bear Creek Road.
  Ms. Zilberfarb will get pricing.
- Committeeman Frank Desiderio asked about signing the intent for the renewal of the MEL insurance. Ms. Zilberfarb explained that the committee wanted quotes and those won't be available until December. Mr. LaSalla is working on those quotes.
- Committeeman Todd McPeek had nothing to report
- Attorney Ed Wacks discussed the house on Route 519 and explained the guidance on unsafe structures and liens on property. A letter will be sent from the attorney explaining that the township will be placing a lien on the property.
- Municipal Clerk Donna Zilberfarb had nothing to report

# **OLD BUSINESS:**

- Salt shed discussed by Mr. Sterbenz during his report.
- Energy Coop Hold until October 2020

### **NEW BUSINESS:**

 Mr. Sterbenz discussed with the committee performing an audit on storm water management over the next couple of weeks for the submittal of the annual report. He is currently preparing updates for stormwater provisions and the land use board will hear those as well as the township committee.

Mr. Sterbenz also briefed the committee on the paving projects. The NJDOT has given clearance to proceed. There will be a preconstruction meeting on 9/24 for Greendell and Stillwater Roads. Paving should start on October 1 and 2. There will be prep work for the dpw to complete prior to milling and paving. The county will also need to place a membrane over the bridge on Greendell road. Mr. Sterbenz explained that all costs will be within budget for both projects.

Mr. Sterbenz let the committee know that he received approval from SHIPO for the salt shed and discussed the different phases of removal and erection. He discussed demo this year and erect the new one next year in the spring. Mr. Ramos discussed what was discussed prior and that the salt shed needed to be demoed and erected in the same time frame. Mr. Ramos will send Mr. Sterbenz a short scope of needs to be done per

their conversation. Approval was given by the committee for Mr. Sterbenz to scope out work and spec everything out and Mr. Sterbenz will bring to the work session meeting in October.

- A letter of resignation by Mr. Sassman from the Recreation committee was accepted with regrets by Mr. Boynton, seconded by Mr. McPeek. All were in favor.
- Mr. Stracco appointed Cheryl Bach to the Land Use Board as an alternate. Motion was made by Mr. Boynton to concur with said appointment, seconded by Mr. Ramos. All were in favor.
- Mr. Stracco appointed Alan DeCarolis as an alternate to the Environmental commission. Motion was made by Mr. Ramos to concur with said appointment, seconded by Mr. Desiderio. All were in favor.
- Mr. Ramos read a letter from the recreation committee regarding booster club funds. After reading the letter Mr. Ramos asked Mr. Desiderio to recuse himself until this matter is taken care of. Mr. Desiderio explained that due to covid it has made it harder to get things completed. Mr. Desiderio stated that the CD had been cashed in and a bank check will be issued and that all should be resolved within a week. He feels there is no conflict of interest and will not recuse himself. Mr. Wacks stated that he should only recuse himself from any issues with booster club and the recreation committee. Mr. Desiderio will give all checks to Danette Dyer, the CFO.

# **DEPARTMENT REPORTS:**

Motion was made by Mr. Ramos for a consent agenda for department reports 1-10, seconded by Mr. Boynton. All were in favor.

DPW – Report in the book. Ms. Zilberfarb questioned the trees that Mr. Boynton discussed and Mr. Desiderio explained to Mr. Boynton that the right of way on South Street is 35 feet and that he believes the tree has been removed already. Mr. Boynton will go back out and look again.

Land Manager – Mr. Conner asked if the old utility poles could be removed from the FFP. Ms. Zilberfarb will ask JCP&L if they are their poles, Marty will get her pole numbers. The committee commented on the monthly reports and that they are nicely done and Marty let the know that Ms. Buttgereit prepares them each month.

Recreation committee – Mr. Ramos let the committee know that they have prepared rules for permit application for the fire pit.

Environmental Commission - no meeting.

Farmland/Open space Committee - no meeting

Historic Committee - no meeting.

# **OPEN MEETING TO THE PUBLIC:**

Motion was made by Mr. Boynton, seconded by Mr. Ramos to open meeting to the public limited to 20 minutes with 3 minutes per member of the public. All were in favor. Spoke were:

- Waclaw Hein spoke of the letter to the booster club and stated that he participated in programs and stated to stop playing games and to give the money and to open up the books for the booster club.
- Mr. Hein also asked about elections for the upcoming general elections and felt it was wrong to have mail in voting. Mr. Stracco understood his concerns but explained that by law all persons will receive a mail in ballot. He explained that due to social distancing our polling place has moved to Frelinghuysen School. The township is awaiting guidelines from the county board of elections.
- Mr. Hein also commented on the dugouts and how they turned out. Mr. Ramos thanked him for volunteering and helping.
- Loren Greco asked about the trees that were discussed for being cut down and removed and asked why Nelson wasn't asked to cut them down. Ms. Zilberfarb was asked to contact JCP&L to discuss.
- Edyta Martewicz asked when Mr. Desiderio would be providing information for the booster club and when all monies would be turned over to the recreation department. Mr. Desiderio stated within a week.

- Dan Kohuth suggested that booster club present at the regular meeting and put it on the agenda.
- Mr. Kohuth also asked about the house at 509 Route 519 and also what was happening
  with the yellow house on Main Street. Mr. Stracco explained that he could not comment at
  this time as it was being discussed during executive session.
- Mr. Kohuth was flabergasted that Nelson wasn't taking the trees in question down. Mr. Stracco explained that these trees have just been brought to our attention.
- Ms. Martewicz asked about working hours for the maintenance workers and if they have a schedule. Mr. Boynton said their hours are currently 7:30 - 3:30 and their schedule varies daily. Mr. Ramos stated that they do a lot of work and do their best with what they have.

Motion was made by Mr. Boynton, seconded by Mr. McPeek to close to the public. All were in favor.
