ORDINANCES:

#2022-11 ORDINANCE RELEASING, EXTINGUISHING AND VACATING THE RIGHTS OF THE PUBLIC IN A PORTION OF STREET KNOWN AS CAMP WEAHQUA ROAD IN THE TOWNSHIP OF FRELINGHUYSEN, COUNTY OF WARREN AND STATE OF NEW JERSEY WHEREAS, a portion of a road known as Camp Weahqua Road, in the Township of Frelinghuysen ("Camp Weahqua Road"), 772.30 feet in length, more or less, and beginning at a point at the intersection of a 33 foot wide right of way known as Camp Weahqua Road where it intersects the centerline of a 33 foot wide right of way, being the original alignment of Bear Creek Road, as fully described in the Schedule attached hereto, is no longer needed for any public purpose, and should be vacated, except to retain certain rights of way and access easements as described in the attached Schedule; and WHEREAS, N.J.S.A. 40:67-1(b) and N.J.S.A. 40:67-19 empower the governing body of a municipality to make, amend, repeal and enforce ordinances to vacate any public street, including the vacation of any portion of any public street. NOW THEREFORE BE IT ORDAINED by the Mayor and Committee of the Township of Frelinghuysen, Warren County, and State of New Jersey, as follows: 1. Subject to the reservations specified in this ordinance, the public rights and interests are hereby vacated with respect to a portion of Camp Weahqua Road, which portion is more specifically set forth in the metes and bounds description which is attached as a Schedule hereto and made a part hereof. 2. All the rights of any and all public utilities, as defined at N.J.S.A. 48:2-13 and cable television companies, as defined at N.J.S.A. 48:5A-1, et seq., to maintain, repair and replace their existing facilities in, adjacent to, over or under the street, or any part thereof, to be vacated are hereby expressly reserved and excepted from this vacation. 3. All of the rights in certain rights of way and access easements as described in the Schedule attached hereto are expressly reserved and excepted from this vacation in perpetuity. 4. Upon final adoption, a copy of this Ordinance shall be transmitted to the Warren County Clerk for recording as required by law. 5. If any article, section, subsection, paragraph, phrase or sentence is, for any reason, held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed severable. 6. All ordinances or parts of ordinances inconsistent herewith are hereby repealed as to such inconsistencies. 7. This Ordinance shall take effect upon final publication as provided by law. NOTICE Notice is hereby given that the foregoing Ordinance was introduced and passed on first reading at the regular meeting of the Frelinghuysen Township Mayor

and Committee held on August 17, 2022 and will be considered for final reading and adoption at a meeting of the Township Committee to be held on September 21, 2012 at 7:30 p.m. at the Municipal Building, 210 Route 661, Johnsonburg, New Jersey at which time and place all interested parties may appear for or against the passage of said Ordinance. Motion was made by Mr. McPeek to open for first reading for introduction, seconded by Mr. Stracco. Roll call vote: Mr. Boynton-absent; Mr. McPeek-Yes; Mr. Ramos-yes; Mr. Stock-yes; Mr. Stracco-yes. Second reading for adoption will be held on September 21, 2022 at 6 pm. Motion was made by Mr. Stracco to open for 2nd reading for adoption, seconded by Mr. Boynton. All were in favor. Mr. Ramos asked for the Committee's thoughts on the ordinance. Mr. Stracco felt it is a short road with very few homes for access and then turned it to the dpw. Mr. McPeek discussed his concern of being able to turn around the larger trucks during inclement weather and stated that the dpw has had to back down the road with lack of turn around area. His other concerns were the cost of maintaining during the winter season and estimated \$2,000.00 for that road alone. Mr. Boynton and Mr. Stock agreed with Mr. McPeek's concerns. Mr. Ramos concurred with the same and stated that it would cost about \$14,000.00 to tar and chip that road. Motion was made by Mr. Stock to open to the public, seconded by Mr. Boynton. All were in favor. Public comment: Marie Luciani asked how many times salted and plowed that road? Mario Luciani disagreed with the turnaround. He stated that the town maintains the road but they don't depend on the town as 99% of the road is plowed by the neighbors and asked when the last time the dpw was there and stated the town has never done anything there, drains etc. He also discussed the bus turnaround and that it makes a mess and now they would need to maintain that as well. He also stated that the tar and chip that was completed will not last and then asked if they have to buy a plow etc. will their taxes be lowered? Mr. Ramos explained that this was financially responsible for the town. Bryan James explained that there are 3 families who pay taxes and green acres behind the road and feels it is a bad idea. He stated the map that was sent out was an older map and that there will still be a section that would have to be maintained. Mr. James also asked about property in the back being land locked and that they'd be closing off the Nature Conservancy. He mentioned the hunting club that utilizes the back land. He also asked if they put up a gate if that would help so the trucks could then turn around better/easier. Mr. Beilin has looked into all of these issues and is confident that nothing is illegal. James also asked about the school bus turnaround. Mr. Ramos explained that would be taken up with the school. Mr. James discussed his understanding of keeping the town financially responsible but explained that this is a community. Mr. Ramos explained that the town doesn't take this lightly and that these are all their own opinions. Mr. Luciani asked about property value and if it would decrease now and if taxes will now go down. Mr. Boynton suggested a site committee as he was concerned with the gate issues. Mr. Ramos stated if consensus to shelf this then he suggested to vote it down. There was no further public comment. Motion was made by Mr. Stracco to close to the public, seconded by Mr. McPeek. All were in favor. Motion was made by Mr. McPeek to approve for adoption, seconded by Mr. Stracco. Roll call: Mr. Boynton-No; Mr. McPeek-yes; Mr. Ramos-yes; Mr. Stock-yes; Mr. Stracco-yes. Ordinance is adopted. Ms. Zilberfarb will send documents to the County Clerk for filing.

#2022-10 ORDINANCE RELEASING, EXTINGUISHING AND VACATING THE RIGHTS OF THE PUBLIC IN A PORTION OF STREET KNOWN AS KERR ROAD IN THE TOWNSHIP OF FRELINGHUYSEN, COUNTY OF WARREN AND STATE OF NEW JERSEY WHEREAS, a portion of a road known as Kerr Road, in the Township of Frelinghuysen ("Kerr Road"), beginning at a point in the northerly right of way line of New Jersey State Highway Route 94 at its intersection with the southerly terminus of a 33 foot wide right of way known as Kerr Road, as fully described in the Schedule attached hereto, is no longer needed for any public purpose, and should be vacated; and WHEREAS, N.J.S.A. 40:67-1(b) and N.J.S.A. 40:67-19 empower the governing body of a municipality to make, amend, repeal and enforce ordinances to vacate any public street, including the vacation of any portion of any public street. NOW THEREFORE BE IT ORDAINED by the Mayor and Committee of the Township of Frelinghuysen, Warren County, and State of New Jersey, as follows:1. The public rights and interests are hereby vacated with respect to a portion of Kerr Road, which portion is more specifically set forth in the metes and bounds description which is attached as a Schedule hereto and made a part hereof. 2. Title to the vacated street shall be apportioned to adjacent property owners, if any, in accordance with law. 3. Pursuant to N.J.S.A. 40:67-1(b), all public easements, rights and interests to the Streets to be Vacated, as more particularly delineated in Exhibit "A" hereto, are hereby vacated, released and extinguished except for said easements and rights specifically set forth herein and except for all rights and privileges now possessed by public utilities, as defined in N.J.S.A. 48:2-13, and by any Cable Television Company, as defined in the "Cable Television Act," N.J.S.A. 48:5A1, et seq., to maintain, repair and replace their existing facilities in, adjacent to, over or under the street, or any part thereof, to Upon final adoption, a copy of this Ordinance shall be transmitted to the Warren County Clerk for recording as required by law. 5. If any article, section, subsection, paragraph, phrase or sentence is, for any reason, held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed severable. 6. All ordinances or parts of ordinances inconsistent herewith are hereby repealed as to such inconsistencies. 7. This Ordinance shall take effect upon final publication as provided by law. **NOTICE** Notice is hereby given that the foregoing Ordinance was introduced and passed on first reading at the regular meeting of the Frelinghuysen Township Mayor and Committee held on August 17, 2022 and will be considered for final reading and adoption at a meeting of the Township Committee to be held on September 21, 2012 at 6:00 p.m. at the Municipal Building, 210 Main Street, Johnsonburg, New Jersey at which time and place all interested parties may appear for or against the passage of said Ordinance. Motion was made by Mr. Stracco to open for first reading for introduction, seconded by Mr. McPeek. Roll call vote: Mr.

Boynton-absent; Mr. McPeek-Yes; Mr. Ramos-yes; Mr. Stock-yes; Mr. Stracco-yes. Second reading for adoption will be held on September 21, 2022 at 6 pm. Motion was made by Mr. Boynton to open for 2nd reading for adoption, seconded by Mr. Stracco. All were in favor. Mr. Ramos asked the Committee their thoughts on this road vacation. Mr. Stracco explained that his concerns were the large properties on each side and was concerned with the access. Mr. McPeek explained his concerns of the turnaround having safety issues and estimated approximately \$3,000 per year to maintain. He stated it isn't maintained and tears up plows and takes longer to plow. Mr. Boynton explained that he wasn't for it years ago and still not for it. He agreed with Mr. Stracco. Mr. Stock explained that he was up in the air and would like to see a map. Mr. Ramos explained that he felt it is a long driveway and that there is a burden to the township financially and stated if tar and chipped today it would cost \$46,700.00. Motion was made by Mr. Boynton to open to the public, seconded by Mr. McPeek. All were in favor. Public comment: The Attorney from McKirdy, Riskin, Olson and DellaPelle handed the Clerk a letter and asked if this has been addressed at the Land Use Board. Mr. Beilin stated there is no procedural defect. The attorney asked if the bridge that is owned by the county would be able to be maintained by the County if road is vacated and this would be land locking property. He explained that if potential development were to occur this would severely impact that. He also discussed emergency vehicles and having access, and public rights on vacating street. Mr. Ramos asked how emergency vehicles would not be accessible and the attorney stated the county bridge would land lock it. Mr. Stracco explained that the values in property would possibly increase as it would be a private road and the property owners would own the easement. Ian Mount respectfully addressed Mr. Stracco and explained that it would not increase the values. The access for farmland utilizes the county bridge and should not abandoned the road. Mr. Stracco explained that if vacated road, then it goes to centerline to property owned. Mr. Mount explained that 10 years ago this was discussed and was put down. He explained that it is important to him as a farmer to access those fields. The property is actively farmed and trucks have been allowed to turn around in Mr. Kapitko's driveway. It was also discussed that Mr. Mount could put a gate up and then Mr. Kapitko would not have access any longer to his property. Mr. Kapitko explained that after the road was rebuilt, that he signed a document stating the trucks could turn around in his driveway. He explained that when the road was rebuilt that the town paid for no equipment or time as he did the work. There was no further public comment. Motion was made by Mr. Boynton to close to the public, seconded by Mr. Stock. All were in favor. Motion was made by Mr. Stracco to approve for adoption, seconded by Mr. McPeek. Roll Call: Mr. Boynton-no; Mr. McPeekyes; Mr. Ramos-no; Mr. Stock-no; Mr. Stracco-no. ORDINANCE DID NOT PASS.

COMMITTEE REPORTS:

- Mayor Ramos explained that Planet Networks will be installing internet at no charge at the FFP with their equipment and the town will pay a monthly cost. Altice is working on Kerrs Corner, Ackerson and Meadow Oak and should be completed the second half of month. He explained that when this process started the town had 3% with high speed internet and it now has 67% of the town covered. Mr. Ramos also discussed working with Paul Sterbenz, Colliers Engineering, on the new storm water regulations and looking at the burden for the town to fight this. Mr. Beilin stated that it is discouraging as they haven't thought about the municipalities. He discussed grants and that some could be competitive. The redesignation will be January 1st but will be phased in. Mr. Ramos also explained that he would like the Clerk to send letters to all the members on the various boards and ask if they wish to remain on the board. These letters will be sent out prior to next year's re-org meeting.
- Deputy Mayor Stracco explained that the Land Use Board memorialized the Master Plan reexamination and will have a resolution for the next meeting.
- Committeeman Boynton told the committee members that the John Lotz sign was hung at the softball field. He reminded the members that this sign was donated by Ed Wacks.
- Committeeman McPeek let the committee that the concrete floor has been poured and the shed was delivered.
- Committeeman Stock Nothing to report
- Municipal Clerk Zilberfarb Nothing to report

Mr. Ramos also let everyone know that at the special meeting on September 29th at 5pm the township will be introducing John Shoemaker and presenting him his Chief's hat.

OLD BUSINESS:

NEW BUSINESS:

- Land use board appointment Motion was made by Mr. Stracco to appoint Dan Rogers to the Land Use Board replacing Max Klein with a one year term until 12/31/2022, seconded by Mr. Boynton. All were in favor.
- Resignation, Amanda Schmidt Motion was made by Mr. Stracco to accept with regrets, seconded by Mr. McPeek. All were in favor.
- Cleaning award Motion was made by Mr. Boynton to award Bedell Brothers for cleaning the townhall at \$85.00 per week and \$65.00 per month for cleaning of the meeting room and award Ocean County Cleaning Services for cleaning the Rec Center at \$125.00 per month both awards on a month to month basis, seconded by Mr. McPeek. All were in favor. Ms. Zilberfarb will reach to both companies.

DEPARTMENT REPORTS: *1-15

Motion was made by Mr. Stracco for a consent agenda for department reports 1-10, seconded by Mr. McPeek. All were in favor.

OPEN MEETING TO THE PUBLIC:

Motion was made by Mr. Stracco, seconded by Mr. Stock limiting it to 20 minutes to open meeting to the public. All were in favor. Spoke were:

- Loren Greco, Greendell Road, asked if Greendell Road would be paved this year. Mr. McPeek stated that it would not, it would be next year.
- Cynthia Mardin, Kerrs Corner Road, explained to the committee that another accident has
 happened at the intersection of Kerrs Corner Road and Silver Lake Road and asked what is
 going to be done. She doesn't want a 4 way stop but feels that solar stop signs would be good,
 and stated that the crashes are disturbing to hear. She explained that the last time she came in
 front of the committee, she was told to speak with the County (Silver Lake Road is a County
 road) and she let the committee know that they put up more signage. Mr. Ramos will have Mr.
 Burns go and look and we will go from there and see if something can be done.
- Marty Connor, Lincoln Laurel Road, had a request for Mr. McPeek and the dpw for about 10 yards of DGA for Robins Trail and asked if they could also run the flail mower down the trail.
 Mr. McPeek stated that they were working on potholes but will get that taken care of.

Motion was made by Mr. Stracco, seconded by Mr. Boynton to close to the public. All were in favor.

Motion was made by Mr. Stracco to enter into executive session, seconded by Mr. Stock.
