New Business:

- Ongoing discussion of fall softball registration and price increase will need to be had at further meetings.
- Changes were made to all recreation forms to reflect that all funds must be deposited into the Recreation Fund Account.
- The difference between the Recreational Fund Account and the Recreation Committee Account was discussed.
- Basketball registration fees were approved. Mr. Stanley made the motion and Mr. McPeek seconded.
- Mr. Stanley will take the soccer registration forms home to look over and approve at the next meeting.
- Softball registration fees were approved. Mr. Ramos made motion and Mr. Sassaman seconded.
- Aerobics, Karate, Tai Chi and Yoga registration fees were approved. Mrs. Winfield made the motion and Mr. Sassaman seconded.
- The township insurance company is requiring certified mulch for the playground. Funding will come out of the Open Space Fund. The mulch will be laid in the spring.
- The committee is looking into railroad ties to keep the mulch in the park and fencing around the park.
- A coaches banquet was discussed in appreciation for all the work they do. Possibly sometime in September or October. We will discuss dates and put together a list of coaches at the next

meeting. The coaches banquet was approved. Mr. Ramos made the motion, Mr. McPeek seconded.

- Founder's Day will be held on 6/6/20. We will look into getting some of the food donated. Our own tables and chairs will be used instead of renting them.

- Mr. Ramos will run a basketball contest for the kids.
